## **GDPR PRIVACY NOTICE**

#### WHAT IS THE PURPOSE OF THIS DOCUMENT?

Capital People Staffing ("the agency" or "we") is committed to protecting the privacy and security of your personal information.

This privacy notice describes how we collect and use personal information about employees of the agency ("employees") and clients of the agency ("clients") (known collectively as "You" or "Your"), in accordance with the General Data Protection Regulation (GDPR).

The agency is a "data controller". This means that we are responsible for deciding how we hold and use personal information about you. We are required under data protection legislation to notify you of the information contained in this privacy notice.

This notice applies to current and former employees and clients. This notice does not form part of any contract of employment or contract to provide services. We may update this notice at any time but if we do so, we will provide you with an updated copy of this notice as soon as reasonably practical.

It is important that you read and retain this notice, together with any other privacy notice we may provide on specific occasions when we are collecting or processing personal information about you, so that you are aware of how and why we are using such information and what your rights are under the data protection legislation.

#### **DATA PROTECTION PRINCIPLES**

We will comply with data protection law. This says that the personal information we hold about you must be:

- 1. Used lawfully, fairly and in a transparent way.
- 2. Collected only for valid purposes that we have clearly explained to you and not used in any way that is incompatible with those purposes.
- 3. Relevant to the purposes we have told You about and limited only to those purposes.
- 4. Accurate and kept up to date.
- 5. Kept only as long as necessary for the purposes we have told you about.
- 6. Kept securely.

## THE KIND OF INFORMATION WE HOLD ABOUT YOU

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

There are "special categories" of more sensitive personal data which require a higher level of protection, such as information about a person's health or sexual orientation.

## **Employees:**

We will collect, store, and use the following categories of personal information about you:

- Personal contact details such as name, title, addresses, telephone numbers, and personal email addresses.
- Date of birth.
- Gender.
- Marital status and dependants.
- Next of kin and emergency contact information.
- National Insurance number.
- Bank account details, payroll records and tax status information.
- Salary, annual leave, pension and benefits information.
- Start date and, if different, the date of an Employee's continuous employment.
- Location of employment or workplace.
- Copy of driving licence (where applicable).
- Recruitment information (including copies of right to work documentation, references and other information included in a CV or cover letter or as part of the application process).
- Employment records (including job titles, work history, working hours, holidays, training records and professional memberships).
- Personnel files and training records including performance information, feedback from clients, disciplinary and grievance information, and working time records.
- Details of any interviews attended with our clients and the client's feedback on those interviews.
- Records of any reportable death, injury, disease or dangerous occurrence.

We may also collect, store and use the following "special categories" of more sensitive personal information:

- Information about your race or ethnicity, religious beliefs and sexual orientation.
- Information about criminal convictions and offences.
- Information about your health, including any medical condition, accident, health and sickness records, including:
  - where an employee leaves employment and under any share plan operated by a group company the reason for leaving is determined to be ill-health, injury or disability, the records relating to that decision;
  - details of any absences (other than holidays) from work including time on statutory parental leave and sick leave; and
  - where an employee leaves employment and the reason for leaving is related to their health, information about that condition needed for pensions and permanent health insurance purposes.

#### Clients:

We will collect, store, and use the following categories of personal information about you:

- Personal contact details such as name, title, addresses, telephone numbers, and email addresses.
- Your job title.
- Any information relating to your personal circumstances, work history and the role which you
  perform within the client organisation which you may provide to us during the course of our
  dealings with you.

#### **HOW IS YOUR PERSONAL INFORMATION COLLECTED?**

#### **Employees:**

We collect personal information about employees through the application and recruitment process, either directly from candidates, referrals or sometimes from an employment agency or background check provider. We may sometimes collect additional information from third parties including former employers, credit reference agencies, other background check agencies or networking sites such as Facebook and LinkedIn.

We will collect additional personal information in the course of job-related activities throughout the period of when an employee works for us.

#### Clients:

We will collect personal information directly from you or the client organisation. We may be provided with personal information about you from your colleagues within the client organisation, your company website or third party networking sites such as LinkedIn.

## HOW WE WILL USE INFORMATION ABOUT YOU

We will only use Your personal information when the law allows us to. Most commonly, we will use your personal information in the following circumstances:

- 1. Where we need to perform the contract we have entered into with You.
- 2. Where we need to comply with a legal obligation.
- 3. Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.

We may also use Your personal information in the following situations, which are likely to be rare:

- 1. Where we need to protect Your interests (or someone else's interests).
- 2. Where it is needed in the public interest or for official purposes.

## Situations in which we will use your personal information

### **Employees:**

We need all the categories of information in the list above (see Employee section within the Paragraph entitled 'The Kind of Information We Hold About You') primarily to allow us to perform our contracts with you and to enable us to comply with legal obligations. The situations in which we will process Employee personal information are listed below.

- Making a decision about your recruitment or appointment.
- Checking you are legally entitled to work in the UK.
- Paying you and if you are a PAYE employee or we are otherwise required to do so for tax purposes, deducting tax and National Insurance contributions (NICs).
- Providing any employee benefits to you.
- Enrolling you in a pension arrangement in accordance with our statutory automatic enrolment duties.
- Liaising with the trustees or managers of a pension arrangement operated by a group company, your pension provider and any other provider of employee benefits.
- Administering the contract we have entered into with you.
- Conducting performance and/or salary reviews, managing performance and determining performance requirements.
- Assessing qualifications and experience for a particular job or task, including decisions about promotions.
- Gathering evidence for possible grievance or disciplinary hearings.
- Making decisions about your continued employment.
- Making arrangements for the termination of our working relationship.
- Education, training and development requirements.
- Dealing with legal disputes involving you, our clients or other employees, including accidents at work.
- · Ascertaining an Employee's fitness to work.
- Managing sickness absence.
- Complying with health and safety obligations.
- To prevent fraud or other crime.
- To monitor your use of our information and communication systems to ensure compliance with our IT policies.
- To ensure network and information security, including preventing unauthorised access to our computer and electronic communications systems and preventing malicious software distribution.
- Equal opportunities monitoring.

Some of the above grounds for processing will overlap and there may be several grounds which justify our use of an Employee's personal information.

#### Clients:

We need all the categories of information in the list above (see Client section within the Paragraph entitled 'The Kind of Information We Hold About You') primarily to build our working relationship with you and to allow us to perform our obligations. In some cases we may use your personal information to pursue legitimate interests of our own or those of third parties, provided your interests and fundamental rights do not override those interests:

The situations in which we will process your personal information are:

- Maintaining regular contact to meet your staffing needs.
- Administering and managing any ongoing staffing services which we are providing to you.
- Obtaining interview and performance feedback regarding staff we provide.
- Obtaining health and safety information in regards to your obligation to our staff.

## If you fail to provide personal information

If employees and clients fail to provide certain information when requested, we may not be able to perform the respective contracts we have entered into with employees and clients, or we may be prevented from complying with our respective legal obligations to employees and clients.

## Change of purpose

We will only use your personal information for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If we need to use your personal information for an unrelated purpose, we will notify the you as is appropriate in the circumstances, and we will explain the legal basis which allows us to do so

Please note that we may process you personal information without your knowledge or consent, as relevant to the circumstances, in compliance with the above rules, where this is required or permitted by law.

#### HOW WE USE PARTICULARLY SENSITIVE PERSONAL INFORMATION (EMPLOYEES)

"Special categories" of particularly sensitive personal information require higher levels of protection. We need to have further justification for collecting, storing and using this type of personal information. We have in place an appropriate policy document and safeguards which we are required by law to maintain when processing such data. We may process special categories of personal information in the following circumstances:

- 1. In limited circumstances, with your explicit written consent.
- 2. Where we need to carry out our legal obligations or exercise rights in connection with employee employment.
- 3. Where it is needed in the public interest, such as for equal opportunities monitoring or in relation to our occupational pension scheme.

Less commonly, we may process this type of information where it is needed in relation to legal claims

or where it is needed to protect your interests (or someone else's interests) and you are not capable of giving consent, or where you have already made the information public.

## The Agency's obligations as an employer

We will use particularly sensitive personal information of Employees in the following ways:

- We will use information relating to leaves of absence, which may include sickness absence or family related leaves, to comply with employment and other laws.
- We will use information about the physical or mental health of an employee, or their disability status, to ensure employee health and safety in the workplace and to assess the fitness of employees to work, to provide appropriate workplace adjustments, to monitor and manage sickness absence and to administer benefits including statutory maternity pay, statutory sick pay, pensions and permanent health insurance.
- We will use information about an employee's race or national or ethnic origin, religious, philosophical or moral beliefs, or an employee's sexual life or sexual orientation, to ensure meaningful equal opportunity monitoring and reporting.

#### Do we need Employee consent?

We do not need the consent of employees if we use special categories of personal information in accordance with our written policy to carry out our legal obligations or exercise specific rights in the field of employment law. In limited circumstances, we may approach you for their written consent to allow us to process certain particularly sensitive data. If we do so, we will provide you with full details of the information that we would like and the reason we need it, so that you can carefully consider whether they wish to consent. You should be aware that it is not a condition of their contract with the nursery that they agree to any request for consent from us.

## **INFORMATION ABOUT CRIMINAL CONVICTIONS (EMPLOYEES)**

We may only use information relating to criminal convictions where the law allows us to do so. This will usually be where such processing is necessary to carry out our obligations and provided we do so in line with our data protection policy.

Less commonly, we may use information relating to criminal convictions where it is necessary in relation to legal claims, where it is necessary to protect the interests of You (or someone else's interests) and You are not capable of giving your consent, or where you have already made the information public.

We envisage that we will hold information about criminal convictions.

We will only collect information about criminal convictions if it is appropriate given the nature of the role and where we are legally able to do so, which includes but is not limited to Disclosure and Barring Service ("DBS") checks. Where appropriate, we will collect information about criminal convictions as part of the recruitment process or we may be notified of such information directly by you in the course of you working for us. We will use information about criminal convictions and offences in the following ways:

 To conduct a DBS check on you when appropriate, to record the date of the DBS check, the number of the DBS check and the name of the body conducting the DBS check. We are allowed to use your personal information in this way to carry out our obligations. We have in place an appropriate policy and safeguards which we are required by law to maintain when processing such data.

#### **DATA SHARING**

We may have to share your data with third parties, including third-party service providers and other entities in the group.

We require third parties to respect the security of Your data and to treat it in accordance with the law.

#### Why might the Agency share your personal information with third parties?

We will share your personal information with third parties where required by law, where it is necessary to administer the working relationship with you or where we have another legitimate interest in doing so. The types of third party with which we might share your personal data for legitimate purposes include staff and clients and third party service providers.

## Which third-party service providers process my personal information?

"Third parties" includes third-party service providers (including contractors and designated agents), and other entities within our group. The following third-party service providers process personal information about you for the following purposes:

- NEST Pension Administration
- Sage Payroll Payroll Processing
- Sage Accounting Accounts Processing
- Close Brothers Accounts Processing
- Fasthosts Web Hosting Services

We will share personal data regarding your participation in any pension arrangement operated by a group company with the trustees or scheme managers of the arrangement in connection with the administration of the arrangements.

#### How secure is my information with third-party service providers and other entities in our group?

All our third-party service providers and other entities in the group are required to take appropriate security measures to protect your personal information in line with our policies. We do not allow our third-party service providers to use your personal data for their own purposes. We only permit them to process your personal data for specified purposes and in accordance with our instructions.

#### **DATA RETENTION**

#### How long will you use my information for?

We will only retain Your personal information for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.. To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve

those purposes through other means, and the applicable legal requirements.

Our standard data retention periods for employees are:

• Seven years after your employment ended in respect to any information which we are required to keep for auditing or HMRC compliance purposes and to comply with our contractual obligations to third parties where your personal data is relevant to such contracts

In some circumstances we may anonymise your personal information so that it can no longer be associated with you, in which case we may use such information without further notice to you. Once you are no longer an employee or client benefiting from the agency's services, as is appropriate, we will retain and securely destroy your personal information in accordance with applicable laws and regulations.

## RIGHTS OF ACCESS, CORRECTION, ERASURE, AND RESTRICTION

## Your duty to inform us of changes

It is important that the personal information we hold about you is accurate and current. Please keep us informed if Your personal information changes during your working relationship with us.

## Your rights in connection with personal information

Under certain circumstances, by law you have the right to:

- Request access to your personal information (commonly known as a "data subject access request"). This enables you to receive a copy of the personal information we hold about you and to check that we are lawfully processing it.
- **Request correction** of the personal information that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you corrected.
- Request erasure of your personal information. This enables you to ask us to delete or remove
  personal information where there is no good reason for us continuing to process it. You also have
  the right to ask us to delete or remove your personal information where you have exercised your
  right to object to processing (see below).
- **Object to processing** of your personal information where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground. You also have the right to object where we are processing your personal information for direct marketing purposes.
- Request the restriction of processing of your personal information. This enables you to ask us to suspend the processing of personal information about you for example if you want us to establish its accuracy or the reason for processing it.
- Request the transfer of your personal information to another party.

If you want to review, verify, correct or request erasure of your personal information, object to the processing of your personal data, or request that we transfer a copy of your personal information to another party, please contact the data protection officer in writing.

## No fee usually required

You will not have to pay a fee to access your personal information (or to exercise any of the other

rights). However, we may charge a reasonable fee if your request for access is clearly unfounded or excessive. Alternatively, we may refuse to comply with the request in such circumstances.

## What we may need from You

We may need to request specific information from you to help us confirm your identity and ensure your right to access the information (or to exercise any of your other rights). This is another appropriate security measure to ensure that personal information is not disclosed to any person who has no right to receive it.

#### **RIGHT TO WITHDRAW CONSENT**

In the limited circumstances where you may have provided your consent to the collection, processing and transfer of your personal information for a specific purpose, you have the right to withdraw your consent for that specific processing at any time. To withdraw your consent, please contact Chantelle Smit, Director on operations@capitalpeoplelondon.com. Once we have received notification that you have withdrawn your consent, we will no longer process your information for the purpose or purposes you originally agreed to, unless we have another legitimate basis for doing so in law.

#### CHANGES TO THIS PRIVACY NOTICE

We reserve the right to update this privacy notice at any time, and we will provide you with a new privacy notice when we make any substantial updates. We may also notify you in other ways from time to time about the processing of your personal information.
